Warrant Officer within the meaning of the Defence Force Discipline Act 1982 with 5 years service, Full-time Teacher at a school, or tertiary education institution, with 5 years service, Registered Nurse, or Enrolled Nurse, with 5 years service, Bank Manager, Bank Officer with 5 years service, Building Society Officer with 5 years service, Credit Union Officer with 5 years service, Registered Member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants, Postal Manager, Australian Postal Corporation Officer with 5 years service, Person before whom a statutory declaration may be made under the law of the State, or Territory, in which the declaration is made, Australian Consular Officer, or Australian Diplomatic Officer, within the meaning of the Consular Fees Act 1985.


