Rules used for elections Rule ID: 052V: Incorporates alterations of 27 February 2015 [R2015/34] (*replaces alterations of 16 February 2015 [R2014/264, R2014/328, R2014/295, R2015/21 and R2015/23052V: Incorporates alterations of 27 February 2015 [R2015/34]*)

Rules difficult to apply/interpret: Stage 2 Election - Rule 41 (e) not clear. The rule requires the Returning Officer attend meetings of all 17 sub-branches where nominations are opened and closed. And where a ballot is required, it must be completed at another meeting of the sub-branch at a later date. To attend all 17 sub branch meetings is logistically difficult and unworkable. In the past AEC has done this via a postal ballot. However, the Union has been advised to consider amending the requirement to attend each meeting as RO unable to be present at all meetings.
