I have received your declaration dated 5 January 2009 providing information in accordance with subsection 233(1) of Schedule 1 of the *Workplace Relations Act 1996*. The documents were lodged in the Industrial Registry on 9 January 2009.

The documents lodged cover the required information for the **2009** Annual Return of the organisation.

I note that the declaration did not provide the required wording contained in section 233(1)(b).

Section 233(1)(b) of the RAO Schedule *requires that*:

*“(b) a copy of the records required to be kept under paragraphs 230(1)(b), (c) and (d), certified by declaration by the secretary or other prescribed officer of the organisation to be a correct statement of the information contained in those records.”*

Also, the declaration did not address the information required by Regulation 147:

*(ii) for an office in a branch of the organisation;”*
