

I acknowledge receipt of your Declaration dated 15 March 2013 which provides information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the Act).

The documents lodged on 15 March 2013 cover some of the requirements set out in s.233 of the Act. However, other aspects of the information which comprise the 2013 annual return of the Australian Municipal, Administrative, Clerical and Services Union's Queensland (Services and Northern Administrative) Branch were not provided.

Therefore, the following further information is required from your Branch before the 2013 annual return can be filed by the Fair Work Commission (the FWC).

- Subsection 230(1)(c) of the Act states that the Branch must keep a record of the "*list of the names, postal addresses and occupations of the persons holding the offices*" in the Branch. Subsection 233(1)(b) obliges the Branch to lodge a copy of that record with the FWC annually. Can you please arrange lodgement of those records in the FWC as soon as is practicable. 


