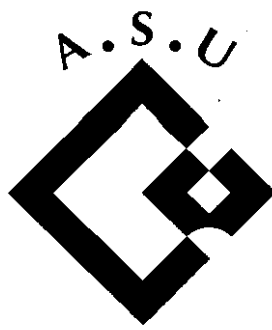
### Electronic lodgment
