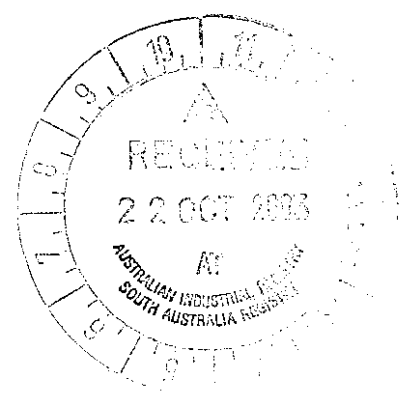

RE Election of National Conference Delegates

Pursuant to Section 214 of the Workplace Relations Act 1996, and pursuant to Division 15 Rule 21 – National Conference Delegates of the Rules of the Australian Municipal Administrative Clerical and Services Union, I advise that elections for the following offices within the Australian Municipal Administrative Clerical and Services Union, South Australian and Northern Territory Branch are due to be held:

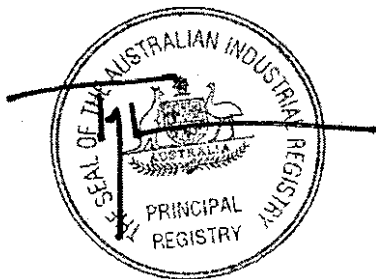
