I acknowledge receipt of your correspondence dated 29 and 31 October 2007 and the prescribed information contained therein regarding the upcoming elections. The documents were lodged with the Registry on 29 and 31 October 2007 respectively. I also refer to the telephone conversation Mr Larry Powell from our office had with you on 30 October 2007.

I confirm that in the telephone conversation of 30 October 2007, Mr Powell advised you that sub-regulation 138(3) of the *Workplace Relations (Registration and Accountability of Organisations) Regulations 2003* requires the prescribed information be lodged at least 2 months before the nominations open.

I wish to further advise that sub-regulation 138(1) requires the prescribed information to also include, amongst other things:

- the date and time of the beginning and end of the period in which nominations of candidates will be called for [reg 138(1)(e)];
- the day on which the roll of voters is to be closed [reg 138(1)(f)]; and
- the kind of voting system to be used in the conduct of the election, whether it be a direct voting system or a collegiate electoral system [reg 138(1)(g)].

In future, can you please ensure the abovementioned sub-regulations are observed.
