#### Annual Return of Information for 2013 [AR2013/252]

I acknowledge receipt on 25 March 2013 of your Declaration providing information in accordance with subsection 233(1) of the Fair Work (Registered Organisations) Act 2009 (the Act).

The documents lodged on 15 March 2013 cover some of the requirements set out in s.233 of the Act. However, other aspects of the information which comprise the 2013 Annual Return of Information were not provided and in another instance, incorrect information was submitted.

Therefore, the following further information is required from your Branch before the 2013 Annual Return can be filed by the Fair Work Commission (the Commission).

• Subsection 233(1)(b) requires the Branch to lodge "a copy of the records required to be kept under paragraphs 230(1)(b) [and] (c)... certified by declaration by the secretary or other prescribed officer of the organisation to be a correct statement of the information contained in those records."

Subsection 230(1)(b) of the Act requires the Branch to keep a record of the offices in the Branch while 230(1)(c) requires you to keep a record of the "list of the names, postal addresses and occupations of the persons holding the offices" in the Branch.

A copy of the records which exist at the time the declaration is made must therefore be lodged, rather than a copy of the records which existed on 31 December of the preceding year.

Can you please submit a list which sets out the offices within the branch, the names of the holders of those offices, their addresses and their occupation details, current at the date of the declaration.

Subregulations 147(b) and (c) of the Fair Work (Registered Organisations) Regulations 2009 require the Branch to keep records of "the name of each branch that commenced operation in the previous 12 months" and "each branch that ceased operation in the previous 12 months" If no branches have commenced or ceased operation, then nil disclosures should be made.

Can you please arrange lodgement of those records in the Commission as soon as is practicable.
