If a website is not available, publishing a notice in a journal or newsletter would be considered appropriate.

Arrangement for conduct of election.

[1] On 8 January 2015 the Taxation Officers Branch of the Australian Municipal, Administrative, Clerical and Services Union lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:
