Supplementary information from the ASU Vic/Tas A & S Branch is provided herewith:

The amendments to the table in our correspondence of the 22nd December 2014 are as follows:

On page 2 where it reads “Branch Executive Industry Divisions” (half way down the table), it should read:

“Branch Executive Members”, not “Branch Executive Industry Divisions”

Reason for this is that “Branch Executive Members” actually refers to the office

On page 3 at the very bottom of the table where it reads “National Conference Delegates (Remaining) – the figure of “13” is incorrect. It should read “12.”

This calculation is based on the figure we provided of 23,854 members. We get 3 votes for the first 1,000 members and then 1 vote for each additional full 1,000.
