**Notification of changes to records required to be kept - Section 233 - *Fair Work (Registered Organisations) Act 2009***

I am writing to you concerning the requirement that an organisation must, within the prescribed period, lodge with the Fair Work Commission notification of any changes made to the records required to be kept in accordance with section 230 of the *Fair Work (Registered Organisations) Act 2009*. Regulation 151 of the *Fair Work (Registered Organisations) Regulations 2009* provides that the prescribed period for notification of changes to records is 35 days after any changes are made.

It appears that the Western Australian Branch of the Australian Nursing and Midwifery Federation may have overlooked this requirement in recent years. As the requirement to notify the Fair Work Commission is incumbent upon an organisation rather than its Branches, I am writing to you to remind the Western Australian Branch and indeed all of the organisation's branches of this requirement.
