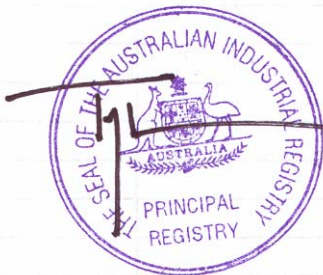

**Request to conduct ANF elections**

I wish to advise that, pursuant to the Rules of the Australian Nursing Federation, elections are due to be held for the positions of:

Federal Secretary,  
Assistant Federal Secretary,  
Federal President (honorary),  
Federal Vice President (honorary).

The positions of Federal Secretary and Assistant Federal Secretary take office from 1 April 2007 to 31 March 2011. The positions of Federal President and Federal Vice President take office from 1 April 2007 to 31 March 2009.

Subject to your approval, it is proposed that nominations should open 0900 Monday 4 December 2006 and close 1200 Friday 22 December 2006. The proposed nomination dates allow for insertion of the election notice in the Federation's journals within the proscribed 21 day period.

It is further proposed, subject to your approval, that the ballot be held between Monday 29 January 2007 and Friday 16 February 2007.
