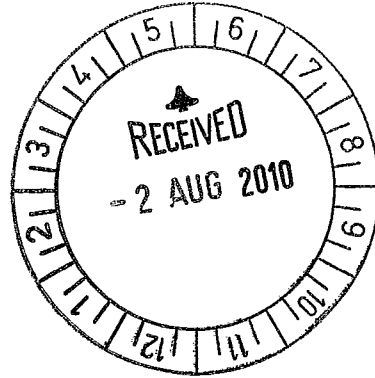

Request to conduct ANF elections

I wish to advise that, pursuant to the Rules of the Australian Nursing Federation, elections are due to be held for the positions of Federal Secretary, Assistant Federal Secretary, Federal President and Federal Vice President.

The terms of office of the Federal Secretary and Assistant Federal Secretary positions are from 1 April 2011 to 31 March 2015. The terms of office of the Federal President and Federal Vice President positions are from 1 April 2011 to 31 March 2013.

Subject to your approval, it is proposed that nominations should open 0900 Monday 1 November 2010 and close 1200 Friday 26 November 2010. The proposed nomination dates allow for insertion of the election notice in the Federation's journals within the prescribed 21 day period.

It is further proposed, subject to your approval, that the ballot be held between Monday 6 December 2010 and Friday 17 December 2010.
