Re: Australian Nursing Federation - New South Wales Branch 2012 Election of Office Holders

This is to notify you that the New South Wales Branch of the Australian Nursing Federation is required under its rules to hold certain elections between 1 September and 30 October 2012.

The prescribed information required by s 189(1) of the RAO Schedule of the Fair Work (Registered Organisations) Act 2009 (the Act) is as follows:

- a) An election is required for the following offices: Branch Secretary (one (1) to be elected) Assistant Branch Secretary (one (1) to be elected) Branch President (one (1) to be elected) Branch Vice President (one (1) to be elected) Branch Executive Member (four (4) to be elected) Branch Councillor (fifteen (15) to be elected);
- b) The reason for the election if that the term of office for these positions is due to expire in the normal course of events on 29 November 2012;
- c) The electorate comprises financial members of the New South Wales Branch of the Australian Nursing Federation;
- d) In relation to the dates for the calling of nominations, the rules provide that the election is to be conducted between 1 September 2012 and 30 October 2012. provided that the Returning Officer may call for nominations prior to 1 September:
- e) The rules (Rule 85.4) provide that the roll of voters for an election is to be closed seven days before the day on which nominations are opened; and

f) The voting system to be used is a direct voting system.

I hereby state that I am the Branch Secretary of the New South Wales Branch of the Australian Nursing Federation and am authorised to sign this statement that the above information is being lodged in accordance with s 189(1) of the Act.
