

Arrangement for conduct of election.

[1] On 15 April 2014 the New South Wales Branch (the Branch) of the Australian Nursing and Midwifery Federation (the ANMF) lodged with the Fair Work Commission (the Commission) the prescribed information in relation to an election for the following offices:

Branch President (1)
Branch Vice President (1)
Branch Executive Member (4)
Branch Councillor (15)

- [2] On 23 April 2014, the Commission wrote to the Branch seeking documentary evidence that the Branch Council had determined that the number of offices of Branch Councillors to be elected would be fifteen (15), pursuant to rule 65.2.3 of the rules of the ANMF.
- [3] On 16 May 2014, the Branch provided a copy of a resolution of a meeting of the Branch Council which determined that the number of offices of Branch Councillor shall be fifteen (15).
- [4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

I refer to the prescribed information dated 10 April 2014 which was lodged with the Fair Work Commission on 15 April 2014 for a scheduled election for the NSW Branch of the Australian Nursing and Midwifery Federation.

The prescribed information includes an election request for 15 Branch Councillors. Rule 65.2.3 of the organisation's rulebook provides that the number of Branch Councillors will be determined by each Branch Council as being between 5 and 20. However no documentation was provided or any copy of a resolution which provides evidence that the number of Councillors to be elected was determined as being 15.

Could you provide the Fair Work Commission with a copy of a resolution or other documentation confirming that the number of Branch Councillors should indeed be 15.



Re: Australian Nursing and Midwifery Federation – New South Wales Branch 2014 Election of Office Holders

This is to notify you that the New South Wales Branch of the Australian Nursing and Midwifery Federation is required under its rules to hold certain elections between 1 September and 30 October 2014.

The prescribed information required by section 189(1) of the RAO Schedule of the Fair Work (Registered Organisations) Act 2009 (the Act) is as follows:

- a) An election is required for the following offices:
 - Branch President (one (1) to be elected)
 - Branch Vice President (one (1) to be elected)
 - Branch Executive Member (four (4) to be elected)
 - Branch Councillor (fifteen (15) to be elected);
- b) The reason for the election is that the term of office for these positions is due to expire in the normal course of events on 29 November 2014;
- c) The electorate comprises financial members of the New South Wales Branch of the Australian Nursing and Midwifery Federation;
- d) In relation to the dates for the calling of nominations, the rules provide that the election is to be conducted between 1 September 2014 and 30 October 2014, provided that the Returning Officer may call for nominations prior to 1 September;
- e) The rules (Rule 85.4) provide that the roll of voters for an election is to be closed seven days before the day on which nominations are opened; and
- f) The voting system to be used is a direct voting system.
