I have received your letter dated 1 March 2005 containing some of the information required to be lodged in accordance with subsection 233(1) of Schedule 1B of the *Workplace Relations Act 1996* (the Act) for the year 2005.

Please note that subsection 233(1)(a) requires that an organisation must lodge in the Industrial Registry once in each year at such time as is prescribed:

“a declaration signed by the secretary or other prescribed officer of the organisation certifying that the register of its members has, during the immediately preceding calendar year, been kept and maintained as required by paragraph 230(1)(a) and subsection 230(2); and.....”

Regulation 147(e) states that certain prescribed information should be lodged in the Registry:

“(e) a record of each election that must, under the rules of the organisation, be held during each year commencing 1 January:”

in this case the year commencing 1 January 2005.
