#### Dear Mr Pfeiffer

Our organisation has received a declaration from the Australian Electoral Commission (AEC) regarding election E2008/E166 ie. the outcome of nominations for positions on Branch Council for the term of office to commence from 30 November 2008. Thirteen eligible nominations were received with the result that an election was not required. Given that the Council membership should be fifteen, this result leaves 2 Ordinary Branch Councillor positions unfilled. ANF (South Australian Branch) Council carried the following resolution at their meeting on Wednesday 15 October 2008.

'That ANF South Australian Branch Council requests the Industrial Registrar to authorise the conduct of elections in accordance with the provisions of the Workplace Relations Act 1996, under section 189 of Schedule 1B, for 2 Ordinary Branch Councillors.'

Please find below information as required under Regulation 138:

- The officers in respect of which the election is required are:
  2 Ordinary Branch Councillors
- 2. The reason for which the election is required is that a casual vacancy in the position will occur from 30 November 2008.
- 3. The electorate for the election is the whole of the Branch.
- 4. The dates and times that nominations open and close are as to be determined by the Australian Electoral Commission.
- 5. The day provided for in the rules of the organisation as the day on which the roll of voters is to be closed is 7 days before the day on which nominations are open.
- 6. The voting system to be used in the conduct of the election is a direct voting system.
