Re: Australian Nursing Federation - South Australian Branch Arrangement for Conduct of an Election - E2011-2524 Fair Work (Registered Organisations) Act 2009 (the RO Act)

I write to advise that Patricia Currie, Branch Councillor has resigned from her role due to accepting a position as an Organiser with the ANF South Australian Branch. A copy of her resignation letter is attached.

Rule 42, Extraordinary Vacancies of the State rules provides that:

if the vacancy occurs more than eighteen (18) calendar months, (thirty-six (36) calendar months if the vacant position is that of Secretary) prior to the first day of September of a year in which an election for such office would be held in accordance with these Rules the Returning Officer shall conduct an election to fill such vacancy for the balance of the unexpired term as far as practicable in accordance with these rules

As a result the following resolution was carried at the Branch Council meeting held on Wednesday 9 February 2011:

That ANF South Australian Branch Council requests the Industrial Registrar to authorise the conduct of an election in accordance with the provisions of the Fair Work (Registered Organisation) Act 2009, under section 189 of Schedule 1B, for a Branch Councillor vacancy arising from the resignation of Ms Patricia Currie effective from 9 February 2011.
