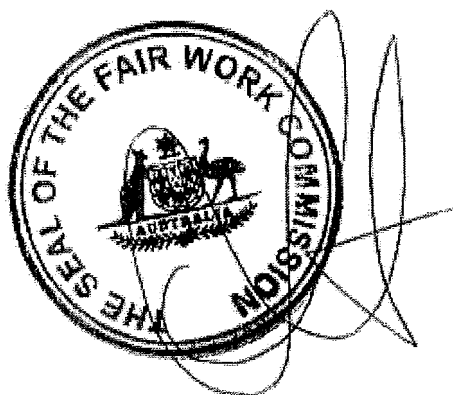

Arising from this, the following motion was carried by Branch Councillors at their meeting on 9 April 2014:



**PRESCRIBED INFORMATION FOR ELECTION  
REGULATION 138 OF SECTION 189(1)**

I am an officer of the Australian Nursing and Midwifery Federation South Australian Branch and am authorised to sign this statement which is lodged in accordance with Regulation 138 of Section 189(1).

1. The officers in respect of which the election is required are all elected positions:

3. The electorate for the election is:


Whole of the Branch.
