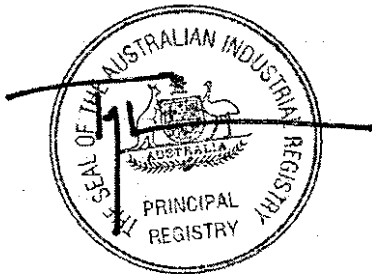

In accordance with the Rule 48 of the Registered Rules of the Australian Nursing Federation and Section 189 of Schedule 1B of the Workplace Relations Act 1996, I am writing to request that you make arrangements with the Australian Electoral Commission to conduct an election for the following office of the Victorian Branch of the Australian Nursing Federation :

One (1) Ordinary Branch Councillor

In accordance with Regulation 138 of the Workplace Relations (Registration and Accountability of Organisations ) Regulations, please be advised of the following information.

The request for the election is due to the resignation of Maurizio Bilotta, an Ordinary Councillor and a copy of his letter of resignation enclosed herewith. Maurizio Bilotta commenced his term of office on 1 December 2003 and Rule 48(c) of the ANF Rules states : "**Where the unexpired part of the term of the office in which the casual vacancy has arisen exceeds that specified in Sub Rule (a) of this Rule that vacancy shall be filled by an election conducted as soon as possible and as far as practicable in accordance with the provisions of these Rules relating to election for the office in question.**".


