# DECISION

*Fair Work (Registered Organisations) Act 2009* s.189—Arrangement for conduct of an election

**Australian Nursing Federation** (E2013/203)

Arrangement for conduct of election.

[1] On 13 June 2013, the Australian Nursing Federation-Western Australian Branch (the Branch) lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices:

Branch President Branch Executive Committee Members (2) Branch Councillors (9)

[2] On the same date, the Branch lodged with the Fair Work Commission the prescribed information in relation to an election for the following offices due to insufficient nominations in E2012/349:

Branch Councillors (2)

[3] Subrule 51.6 of the organisation provides that where an election has been held pursuant to the Rules for any office in the Federation or a Branch and no person has been elected, a further election shall be conducted as though a casual vacancy existed and so far as practicable the provisions of Rule 51 apply. Subrule 51.3 provides that where an election is required to fill a vacancy, such election shall be conducted as soon as practicable. I note that the election for the Branch Councillor offices in E2012/349 was declared on 24 October 2012 and the prescribed information currently before me requesting an election due to insufficient nominations for those offices was lodged in the Fair Work Commission on 13 June 2013, some eight months after the declaration. Such a period would appear to not meet the requirement for an election to be held "as soon as possible" as required by subrule 51.3. Future prescribed information in relation to casual vacancies or insufficient nominations should be lodged with the Fair Work Commission in a more timely manner.

[4] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

#### **Reasons for election:**

 Election for offices and positions is required as the terms of office are due to expire in the normal course of events under the rules of the organisation.

#### Elected by:

The electorate for the direct voting system is the whole of the Branch.

#### Nominations open:

For offices to elected by direct voting system – after 1 July

#### Nominations close:

For offices to be elected by direct voting system no later than - 12 noon, 31<sup>st</sup> August

#### Cut off date for roll:

In all cases - 7 days prior to the opening date for nominations - rule 85.4
