**Section 233 Fair Work (Registered Organisations) Act 2009 – RO Act
Obligation to lodge information with FWA
Annual Return information for 2009 – AR2008/307**

I acknowledge receipt of the further declaration dated 22 October 2009 providing new information for the 2008 Annual Return. The document was lodged with Fair Work Australia on 23 October 2009. A previous declaration to the 2008 Annual Return was lodged on 16 January 2008.

This further declaration provided additional information from the prescribed records kept by the organisation required under regulation 147 of the *Fair Work (Registered Organisations) Regulations 2009* (RO Regulations).
