**Section 233 - Obligation to lodge information with Fair Work Australia
Annual Return of Information for year 2012 – AR 2012/413 and AR2012/416**

Thank you for the 2012 annual returns (two) made in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the Act) for the Federal Office and the Victorian Branch of the Australian Principals Federation. The documents were lodged with Fair Work Australia on 14 March 2012.

The documents have been filed and no further action is requested. I draw your attention, however, to section 230(1)(d) of the Act and Regulation 147 of the *Fair Work (Registered Organisations) Regulations 2009*, which require the annual returns to include a record of each election that will become due in the course of the year within the Federal Office and the Victorian Branch. There was no information about forthcoming elections in the Federal return, and the reference to the “current casual vacancies” expressed in the Victorian Branch return does not sufficiently meet the legislative requirement. More detail in future years is requested concerning elections. If no election is due in the forthcoming year, then the annual return should indicate that fact.
