Statement and Notice of Prescribed Information under Regulation 136

Reason for Elections

Casual vacancies arising from no nominations having been received at by-elections of Victorian Council members conducted by the Australian Electoral Commission as a fee for service election in May 2009 in all above Regions (see Declaration Letter and Declaration Uncontested Offices letter from Tony King from AEC attached)

The vacancies arose as a result of the following circumstances:

- Andrew Dalgleish elected to Primary Sector Representative Grampians Region December 2007, resigned from Council 20/02/09 (see email attached)
- Sally Rule elected in by-election April 2008 as Primary Sector Representative for Loddon-Mallee Region, is on leave from the Department of Education and moved to Dubai for all of 2009 according to the school at which she is substantive Principal. She has not responded to endeavours to contact her seeking her formal resignation (see email to her attached dated 19/03/09). Ms Rule has been unfinancial for all of 2009 and is therefore ineligible to be on Council anyway.
- Peter Dredge elected to Secondary Sector Representative, Grampians Region December 2007 resigned from Council 23/03/2009 (see email attached)
- Michael Janson elected to Secondary Sector Representative, Western Metropolitan Region December 2007 resigned from Council 14/04/2008 (see email attached).

According to APF Rule 47(23)(b) where the unexpired portion of a vacant term of office is greater than 12 months the vacancy shall be filled by election. Since the term of office for each of the above expires December 2010 Rule 47(23)(b) applies.
