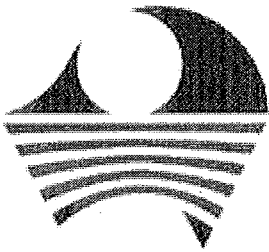

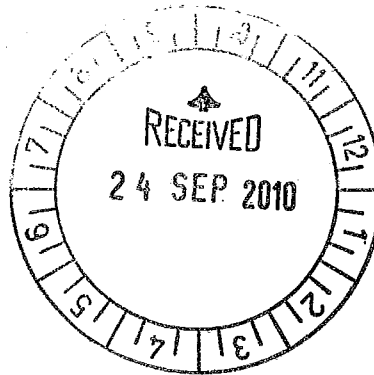

Here we go again. Attached please find the application for both Federal and Vic Branch elections of the APF.

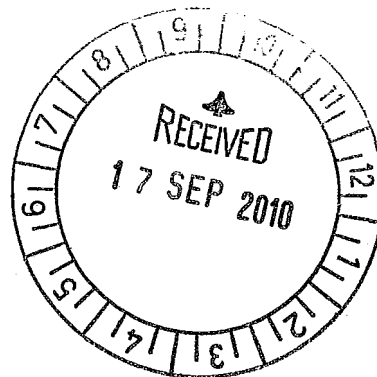
We have not filled all vacancies so nomination will have to be called for the vacant positions. Western Australia is in the same position and they will forward the vacancies in due course.

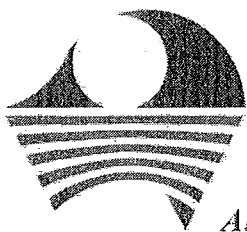

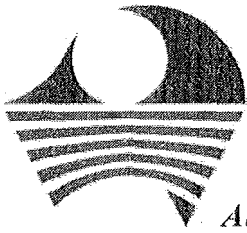
