6. The date and time of the end of the nomination period is not later than 21 days

after at 5.00pm after nominations open in accordance with Rules 21(e) (ii) & (iii) and 47(10) (h) (ii) & (iii). [Regulation 138 (1) (e)]

7. The day upon which the roll of voter's closes is seven days prior to the opening

of nominations in accordance with Rules 21(e)(xv) and 47(10)(h)(xv).
