# Arrangements for the conduct of an Election (E2013/190)

A copy of the decision in relation to the above matter is enclosed.

The Fair Work Commission is making arrangements, under subsections 189(3) of the *Fair Work (Registered Organisations) Act 2009*, with the Electoral Commissioner for the conduct of the subject election by a member of staff of the Australian Electoral Commission, who will contact you in the near future about the election.

After analysis of the Association's rulebook for this election, I noticed an ambiguity in rule 15. Subrule 15(r) provides that elections will be declared at the Annual General Meeting in the month of September, and in every fourth year following. The ambiguity arises in sub-rule 15(s), which refers to the "annual election" of officers on the Executive Committee.

Accordingly, I recommend that an alteration be made to sub-rule 15(s) of the rulebook to remove any ambiguity regarding the phrase "annual election". Specifically, I recommend replacing the words "annual election" with "the Annual General Meeting".
