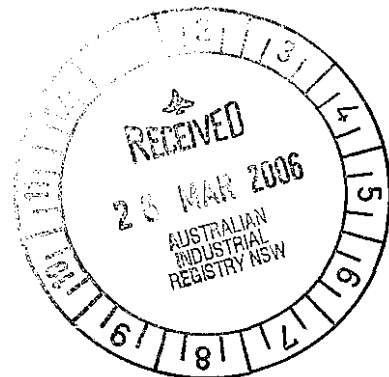



This Operating Report covers:

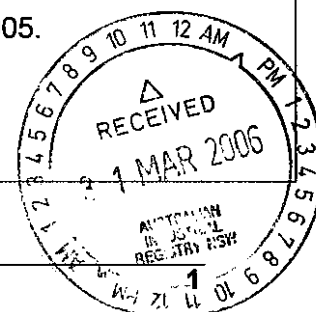
- the activities of the Rail, Tram & Bus Union (RTBU) NSW Branch, for the calendar year 1 January 2005 to 31 December 2005;

1. The Principle Activities & Results Of The Activities of the National Council

The RTBU (NSW) is a member based, federally register trade union representing members whose usual place of work is located within the State of New South Wales (NSW) and the Australian Capital Territory (ACT) together with members employed rail, tram (light rail) and government owned and operated bus industries. The reporting unit's activities are directed by the NSW Branch Council in accordance with its objectives and rules of registration.

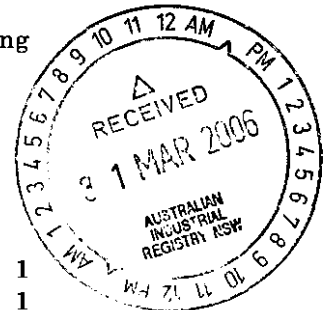

**Re: Annual Return of Information Contained in Records Kept by Organisation –

I am writing in relation to the reporting obligations under s233 of the RAO Schedule - formerly Schedule 1B, now Schedule 1 - of the *Workplace Relations Act 1996*. This issue arose from a query from your office about what documents needed to be lodged by the National Office. From time to time the Registry revisits particular procedures or approaches with a view to ensuring it reflects as correctly as it can the intent of the legislation, and this was such an opportunity.

I note that for a number of years it has been a practice where the Australian Rail, Tram and Bus Industry Union is concerned that each Branch lodges annual returns of information relating to its members and officeholders directly and separately in the Registry.

There are undoubtedly historical reasons for this. Looking back over the records of the Australian Railways Union I note that the first return of office-holders by a Branch was that of the New South Wales Branch on 10 June 1930. Separate returns of office-holders were lodged by the Victorian and South Australian Branches in 1948 and 1949. This has continued under the various legislative regimes of amendments to the *Conciliation and Arbitration Act 1904* and its successor legislation.

I am naturally reluctant to regard as a practical problem what by long practice has been accepted by the Registry but it did occur to me that technically, the obligation to report and lodge under s233 and in accordance with RAO regulation 147 is one that falls on the organisation not its branches.

RAO regulation 150 defines the “prescribed officer for lodging information” as either the secretary or other officer who is required by the rules of the organisation to keep the records mentioned in s230. Under the organisation’s rules, both the National Secretary, in Rule 38(vi) and the Branch Secretaries, in Rule 54 (viii), have a responsibility for preparing and keeping files and records required by the Act.

However I do not think that this qualifies the explicit references to the “organisation” in the legislation. An organisation is defined in section 6 of the RAO Schedule as “*an organisation registered under this Schedule*”.

Moreover, the types of some of the records which are itemised in regulation 147, such as 147(a), 147(b), and 147(c) appear to be the types of records about which it would be appropriate for an officer of the whole organisation - rather than of a constituent Branch - to lodge.


I understand that the National Office receives from each Branch copies of the annual return information pertaining to each Branch's members and officeholders which the Branch has prepared. It seems to me that it should present little difficulty if in future this information and the various records were simply collated by the National Office and lodged under cover of the appropriate declarations by the National Secretary.

The Registry has already received information pursuant to s233 from the Western Australian and New South Wales Branches, and Mr Christison and Mr Lewocki have been sent acknowledgements from the Registry. Perhaps the information and records pertaining to the other Branches can be lodged along with the records prepared by the National Office.

I would like to emphasise that the issue is one of strict technical compliance that the organisation might consider is in their best interests to observe, rather than any deficiency in the substance of the information which the organisation and its Branches have lodged in the past.

Your comments would be appreciated. If you would like to discuss this, if you foreshadow any difficulties in adopting the approach I suggest or if you hold an alternative view, please do not hesitate to contact me at the Registry on 8374 6509.
