**Re: Annual Return of Information Contained in Records of Organisation - s233 Fair Work (Registered Organisations) Act 2009 - Australian Rail, Tram and Bus Industry Union (AR2013/134)**

The Fair Work Commission has received your declaration ("Statement") dated 31 March 2013 and copies of documents providing information in accordance with sub-section 233(1) of the *Fair Work (Registered Organisations) Act 2009* ('the Act'). The documents were lodged on 4 April 2013.

The documents lodged cover the following information:

- Number of members as at 31 December 2012;
- Declaration that the register of members was maintained as required by section 230;
- List of offices of the organisation and the persons holding those offices;
- The address of the office of the organisation;
- A statement that elections due in 2012 have been carried over into 2013.

I must draw your attention to one technical detail where future Statements might more strictly comply with the requirements of the Act. The wording of sub-section 233(1)(b) provides as follows:

*"(b) a copy of the records required to be kept under paragraphs 230(1)(b), (c), and (d) certified by declaration by the secretary.....to be a correct statement of the information contained in those records."*

This provision means that the Statement should explicitly declare or certify that the copies of the records lodged are a correct statement of the information contained in the prescribed records.

Paragraph 6 of your Statement states that a *"list of the office, office holders, occupations and addresses....has been kept as required by paragraph 230(1)(b) and s230(1)(c) ....and is attached as Annexure A"*. Paragraph 7 states that a *record of the number of members.....as at 31 December 2012 is attached at Annexure B"*.

The wording of paragraphs 6 and 7 might be thought to have been intended to mean what the Act intends, and it is consistent with Statements lodged by the organisation in previous years.

Moreover I note that declarations are not uniformly worded by different organisations. However, for the avoidance of doubt that the organisation has complied, and in the interests of greater consistency in lodgements under this section of the Act, I would ask that in future years, the Statement include an explicit declaration that the copies of records lodged are a correct statement of the information contained in the records kept under the relevant paragraphs. I attach an example for your reference and comparison.

The documents have been filed, and there is no further action required in respect of this return.


## STATEMENT
