

### Re: Election E No 263 of 2004.

I write in reference to the biennial elections for National and Branch positions within the Australian Rail Tram and Bus Industry Union (Election E No 263 of 2004). It has been drawn to my attention that there has been a shortfall in the number of vacancies advertised for positions related to the Branch Council in the case of South Australia/ Northern Territory Branch.

There were no Sub-divisional positions allocated to Port Lincoln or Whyalla as a result of Rule changes which became effective in February of 2003.

It is our opinion that in accordance with the rules, the TA/PTB District, and the Pacific National District respectively the call for nominations warranted two (2) positions and that in the case of the two Sub-Divisions vacancies existed for the positions of Secretary, President and Vice President at both Port Lincoln and Whyalla.

The RTBU rules in Part X11 – South Australian and Northern Territory Branch: Specific Provisions at Rule 131(1) describes the composition of the Branch Council, listing the elected officers "together with Delegates from Branch Districts determined in accordance with Sub rule 131 (2).

Sub Rule 131(2) provides that "each District shall be entitled to one Delegate for each two hundred members or part thereof provided that a District shall only be entitled to a Delegate if it has a minimum of twenty five members".

On this basis we contend that the TA/PTB District, which comprises some 300 members, and Pacific National District which comprises some 226 members are entitled to elect two Delegates to the Branch Council.

In 2002, the Branch Council determined to establish Sub Divisions at Whyalla and at Port Lincoln. These Sub Divisions comprise all members at each of these locations, and were established to enable participation in the affairs of the Union by the members in Whyalla and Port Lincoln.

The Union submitted the necessary declarations and concerning alterations to the rule on 14<sup>th</sup> January 2003 and the documentation is attached together with the certificate issued by the Deputy Industrial Registrar on 5<sup>th</sup> February 2003.

We would therefore request that consideration be given to the calling for nominations for these positions in the supplementary elections advice for which was received from the AEC Returning Officer on 15<sup>th</sup> December 2004.

#### re: RTBU SUPPLEMENTARY ELECTIONS

I refer to your correspondence of 11<sup>th</sup> January concerning shortfalls of Elected Officers for the South Australian and Northern Territory Branch and your e-mail of 13<sup>th</sup> January – a request by the Tasmanian Branch to include a Branch Divisional Delegate to the Branch Council, Tram and Bus Division due to a recent resignation.

In relation to the SA and NT Branch position, I am able to confirm that the Union did not include the District membership figures provided at the time. I have checked with our SA and NT Branch and confirm that the membership of TA/PTB District is 300 and the Pacific National District is 226, thus entitling both to elect two (2) delegates to Branch Council. They are the only Districts affected.

The other matter affecting the SA and NT Branch is the non-inclusion of the Sub-Division positions for Whyalla and Pt Lincoln. I believe both the Union and The Registry missed these positions as the rules were varied in January, 2003 and most likely the parties worked-off the Rule Book consolidation 139V: Certified 20/8/2002.

In respect of Tasmania, I am able to confirm the advice from the Branch about the recent resignation of Lecandra Wilson and support their request for the position to be included in the Supplementary Elections.

Your assistance in progressing these matters would be appreciated.

I refer to your letter of 14 January 2005 concerning elections, which appear to be required for the following offices in the organisation.

If possible, the information for all offices could be lodged at once, under your signature avoiding the necessity for separate notices.




