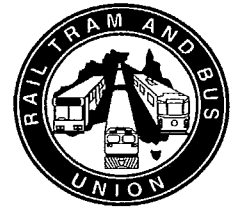



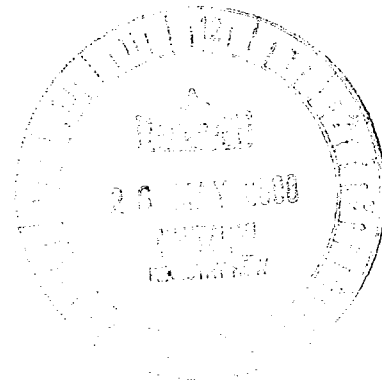
The reason for the vacancy is due to resignation from employer. A copy of the resignation is attached for your reference.
