- Declaration in respect of the register of members of the organisation was provided by the National Office Australian Rail, Tram and Bus Industry Union return.
- List of offices of the organisation and of the persons holding those offices.
- The addresses of the offices of the organisation .
- a statement listing that elections must be held according to your organisation's rules during the year commencing 1 January 2005

These documents meet the requirements of the Workplace Relations Act 1996 and have now been filed.

You will be aware that the *Workplace Relations Act 1996* has been amended so that The Registration and Accountability of Organisations Schedule (Schedule 1B to the *Workplace Relations Act 1996*) **[the RAO Schedule** now contains most of the matters which relate to the registration and functioning of organisations of employers and employees under the Act. A statutory declaration is no longer required. A notification of a change can be certified by a declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the changes made [s233(2)and reg. 148].

The legislative reference for the statement regarding number of members is required under Reg 147(f) of WR (Registration and Accountability of Organisations) Regulations 2003, not Reg 43(1) as stated.
