I write in relation to your request for an election to fill casual vacancies pursuant to subsection 189(1) of the RAO Schedule, which was lodged in the Registry on 8 February 2008. I apologise for the delay in providing my response.

Before I can be satisfied that vacancies exist and that I can approve arrangements for the conduct of the election, I require further information and clarification in relation to a number of positions, firstly, those positions where you have stated that the "[b]earer ceased to hold office in accordance with the rules". I would appreciate a response to my previous correspondence by Friday 20 June 2008.

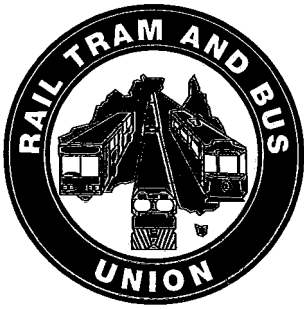
