The amended annual return of information was received at Fair Work Australia on 6 April 2010.

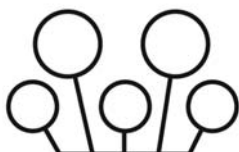


