Declaration and information lodged under subsection 233(1) [Annual Return] for 2019 [AR2019/79]

I acknowledge receipt by the Registered Organisations Commission (**the ROC**) on 11 February 2019 of your organisation's Annual Return which provides information under subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (**the RO Act**).

The documents lodged together with the clarification set out below provide the required information for the 2019 Annual Return of the Australian Road Transport Industrial Organization (**the organisation**).

The Annual Return has been filed. Annual returns are publicly available on the website through the [List of Registered Organisations](#).

The ROC aims to help organisations comply with all the requirements of subsection 233(1) of the RO Act. Accordingly on 29 March 2019 the ROC requested further information from the organisation to identify the street address of the organisation's Tasmanian Branch, which information was provided by the organisation on 8 April 2019.

The Australian Road Transport Industrial Organization confirmed that the street address of the Tasmanian Branch is **769 Melrose Rd, Melrose, Tasmania 7310**.

While no further action is required in relation to this Annual Return, we request that the records kept by the organisation are amended to record this address for the branch, in place of the currently listed PO Box number, consistent with the requirements in the *Fair Work (Registered Organisation) Regulations 2009*. We note for your assistance that any such change to the records would give rise to a change that will need to be notified under subsection 233(2) of the RO Act.

The annual return lodged by the organisation provided two lists of its offices at separate times, being as at 31 December 2018 and as at 7 February 2019 (being the date of declaration). Consistently with consultation held with the organisation, it is unnecessary to provide a list of the names, postal addresses and occupation of persons holding office as at 31 December in each year. Rather, the ROC as a matter of policy asks that organisations provide a copy of the records that it keeps that is accurate as at the time of signing the declaration.

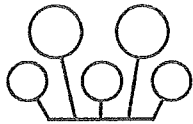
