The election for the offices set out above are due to be conducted under the rules of the organisation and the branches.

#### **Elected by:**

##### Branches

The electorates of the branch offices required to be elected by direct election comprise all members of the respective branch, subject to the financial status of such members entitling members the right to vote.

Note that Branch Representatives (and Alternative Representative) to Council may hold dual office with other offices of the Branch

All other branch positions are by collegiate election

##### National

The electorate of the national Secretary/Treasurer required to be elected by direct election comprise all members of the organisation, subject to the financial status of such members entitling members the right to vote.

All other national positions are by collegiate election.

#### **Nominations open and close :**

As the elections are running late the nominations should open and close at the earliest dates practicable under the rules, using the time frames for the nomination periods as a guide.

#### **Roll of voters to be closed:**

Should any ballots be necessary the rules provide that "The roll of voters for any ballot shall close seven days before the day on which nominations for the election open."
