Officer and related party disclosure statement under 293J [ORP Statement] for 30 June 2018 [ORP2018/1335]

I acknowledge receipt by the Registered Organisations Commission (the ROC) on 14 November 2018 of your organisation's ORP Statement which provides information required to be lodged under subsection 293J of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).

Thank you for providing your ORP Statement. The ORP Statement has been filed and no further action is required.

The ROC understands that not all organisations and branches have five or more officers who receive relevant remuneration or have made payments to related-parties. Section 293J of the RO Act does not require an organisation or branch to explicitly state that certain items were 'nil'. However it is the view of the ROC that such statements would provide greater clarity and transparency for members. Such statements reassure the organisation's members and the ROC that the organisation or branch has turned its attention to the question of officers' relevant remuneration, their non-cash benefits and payments to related parties.

Accordingly, the ROC encourages the organisation, in future, to use the ORP Statement template (available on the <u>fact-sheets</u> page of our website) without removing the tables that appear in the template. For example, along with the organisation's statements stating that no officers received relevant remuneration or non-cash benefits and it did not make any payments to related parties, the organisation should also insert the word "NIL" in each column of the tables.

Time frames

Section 293J requires that the ORP Statement is provided to members and a copy lodged with the ROC within 6 months of the end of the organisation's financial year.


