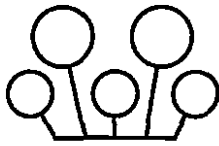



Good afternoon, Mr McMaster

Thank you for lodging the Annual Return of Information in relation to your Branch on 28 February 2013.

I apologise for not having reviewed the documents until now.

There are a few matters that need to be amended before the Annual Return can be finalised for our purposes.

1. I note that as Attachment D, you have enclosed the results of the 2012 election. The information required at this time is in relation to what elections are due during the next 12 months. You need to include a statement that "No elections are due during 2013." (or "The next elections are due in 2014.")
2. The Annual Return that you have lodged does not include a statement of the Branch name and Branch address. We are able to extract the name and address from the Annual Return lodged by the ARTIO national office but it is generally expected to be part of the Branch Annual Return as well.
3. Lastly, but most important, section 233(1)(b) of the *Fair Work (Registered Organisations) Act 2009* (the Act) requires that the information is "**certified by declaration by the secretary or other prescribed officer of the organisation to be a correct statement of the information contained in those records**". Although you have declared that the Registered of Members has been kept and maintained as required by the Act, the other information that you are lodging in the Annual Return must also be declared as a correct statement.

You need to lodge the complete Annual Return of Information under cover of the declaration as defined before I can finalise this Annual Return.

In addition, I need to draw to your attention:

On 18 January 2013, you sent an email with information that your Branch was changing address. Under section 233(2) of the Act, within 35 days of the change, this should have been "certified by declaration signed by the secretary or other prescribed officer of the organisation to be a correct statement of the changes made." Since you lodged the Annual Return of Information on 28 February, I won't require further action in relation to the address change but please be aware of the need for the declaration for the future.

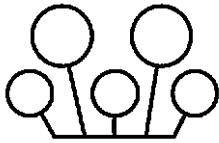


