Unfortunately the Declaration has a number of concerns that will need to be addressed before the Fair Work Commission can file the annual return.

Paragraph 233(1)(b) of the Act requires a list of offices in the organisation. While the Declaration you have provided the Commission identifies a list of office holders, there is no list of offices provided.

I note that the addresses of your office holders provided to the Commission appear to be personal addresses. You may wish to consider changing these addresses to their place of business as the annual returns of the branch are public documents that are accessible on our website.

Paragraph 233(1)(b) of the Act requires a record of each election that must, under the rules of the organisation, be held during each calendar year commencing 1 January for any offices in the organisation and branches of the organisation. The information contained in your Declaration does not address the record of election for the calendar year commencing 1 January 2013.

Please send an amended Declaration addressing the above issues to the Commission as soon as possible.
