Arrangement for conduct of election.

### **DECISION**

[1] On 19 January 2006, the Western Australian Branch of the abovenamed organisation lodged in the Industrial Registry the prescribed information in relation to an election for the following offices;

President Vice-Presidents (2) Secretary/Treasurer Branch Committee

- [2] Other than the Branch Committee, I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of Schedule 1 of the Workplace Relations Act 1996, I am making arrangements for the conduct of the election by the Australian Electoral Commission.
- [3] With respect to the Branch Committee, Rule 20 of the rules of the Australian Road Transport Industrial Organization, Western Australian Branch provides for the election of Branch Committee Members. Rule 22 then provides for an electoral process which commences at the first meeting of the Branch Committee elected in accordance with Rule 20. In summary, those Branch Committee Members elect by and from their number office bearers, namely a President, two Vice-Presidents and a Secretary/Treasurer. In my view the reference to "Branch Committee Member (2)" in rule 22(1) merely recognises that those Branch Committee Members who are not elected to office bearer positions remain nonetheless Officers of the Branch Committee within the meaning of that rule and for the purposes of the rules generally.
- [4] I recently made arrangements for the conduct of an election of six Branch Committee Members (E2006/133; PR972538 refers). I am therefore not satisfied the present prescribed information relevantly pertains to an election which is required to be held under the rules of the organisation. I refuse the application so far as it relates to Branch Committee.
