### Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Commission a declaration of results for the election [E2015/55]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Fair Work Commission (the Commission) within 35 days of any changes to the holders of office in the organisation. If the election has resulted in any changes to the holders of office, the Australian Salaried Medical Officers Federation must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;
  - the name of the person now holding the office;
  - the postal address of the person (generally the postal address of the organisation); and
  - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Rules difficult to apply/interpret:

[132N: Incorporates alterations of 23 January 2015 [R2014/327]]

1. Rule 64 does not provide a mechanism for what to do when two or more candidates receive the same number of votes for a Branch Council position. I recommend that a rule similar to 65 (m) be included in the rules for Branch Council positions.

2. In regards to Rule 65 (m), the reference to drawing by lot in front of at least one scrutineer should be deleted. This part of the rule is defective as a scrutineer may or may not be present. This could be changed instead to a *signed witness* if the presence of a witness is required.

3. A number of the rules state that the closing of the ballot shall be fourteen days, for example Rule  $66 \ 1 \ (f) \ (i)$  – this does not provide sufficient time for the return of ballot papers for ASMOF members who are overseas.

ASMOF may also want to consider adding to the rules a provision for the appointment of a proxy to vote on an absentee's behalf at elections to offices. The rules currently do not cater for this and there were a number of issues with eligible members being overseas at the time of voting. Rule 32 and 59 should include proxy voting for elections to Office in addition to normal business


