I refer to our recent discussions concerning a Certificate of Exemption for the financial year ended 31 December 2002. Certificates have been issued for previous years and for the financial year ended 31 December 2003 (copy attached).

On behalf of the Australian Salaried Medical Officer's Federation, Western Australian Branch ('the Federation'), I would like to apply for a certificate pursuant to section 271 (1) of the Workplace Relations Act 1996 ('the Act') for the Financial years ended December 2002 and December 2004.

The grounds on which the Applications are made are as follows:

- 1. The federation is a Branch of the Australian Salaried Medical Officers Federation which is registered as an organisation under the Act (Organisation No. 132N).
- 2. The Branch compliments the State registered Australian Medical Association (Western Australia) Incorporated ('the Association').
- 3. The Association maintains a number of industrial agreements and is pre-eminent at a State level.
- 4. The Association maintains financial records in accordance with the Western Australian Associations Incorporation Act 1987.
- 5. The membership of the Federation is a subset of the membership of the Association.
- 6. A co-joint membership arrangement exists between the Association and the Federation through which the Federation recognises the pre eminent role of the Association. The Association provides industrial advice and representations services on behalf of Branch members. No industrial agreements or industrial activity is currently being undertaken by this Branch.

- 9. # Workplace Relations Legislation Amendment (Registration and Accountability of Organisations) (Consequential Provisions) Act 2002 subitem 47(1) - continued application of Division 11 of Part IX of Workplace Relations Act 1996

# AUSTRALIAN SALARIED MEDICAL OFFICERS FEDERATION (FR2003/767)

#### **CERTIFICATE**

On 16 June 2004 an application was made under former subsection 271A(1) of the Workplace Relations Act 1996 (the WR Act) for a certificate of exemption by the Western Australian Branch of the Australian Salaried Medical Officers Federation in respect of financial year ended 31 December 2003. Subsection 271A(1) was a provision of Part IX, Division 11 of the WR Act, that division being repealed on 12 May 2003 by the Workplace Relations Legislation Amendment (Registration and Accountability of Organisations) (Consequential Provisions) Act 2002 (the RAOCP Act). However, by virtue of subitem 47(1) of the RAOCP Act, the operation of Part IX, Division 11 of the WR Act continues to apply to the Western Australian Branch of the Australian Salaried Medical Officers Federation in respect of financial year ended 31 December 2003.

Under the provisions of subitem 47(1) of the RAOCP Act and former subsection 271A(1) of the WR Act, I am satisfied that the branch did not have any financial affairs in the year ended 31 December 2003.
