I refer to Mr Stewart's letter dated 9 February 2005 (attached) along with the certificate of Exemption for the financial year ended 31 December 2004. Certificates have also been issued for previous years.

On behalf of the *Australian Salaried Medical Officer's Federation, Western Australian Branch ('the Federation')*, I would like to apply for a certificate pursuant to section 271 (1) of the *Workplace Relations Act 1996 ('the Act')* for the Financial year ended Dccember 2005.

The grounds on which the Applications are made are as follows:

1. The federation is a Branch of the *Australian Salaried Medical Officers Federation* which is registered as an organisation under the Act (Organisation No. 132N).
2. The Branch compliments the State registered *Australian Medical Association (Western Australia) Incorporated ('the Association')*.
3. The Association maintains a number of industrial agreements and is pre-eminent at a State level.
4. The Association maintains financial records in accordance with the *Western Australian Associations Incorporation Act 1987*.
5. The membership of the Federation is a subset of the membership of the Association.
6. A co-joint membership arrangement exists between the Association and the Federation through which the Federation recognises the pre eminent role of the Association. The Association provides industrial advice and representations services on behalf of Branch members. No industrial agreements or industrial activity is currently being undertaken by this Branch.


