### DECISION

*Fair Work (Registered Organisations) Act 2009* s.189—Arrangement for conduct of an election

**Australian Trainers' Association** (E2020/174)

Arrangement for conduct of election.

[1] On 26 August 2020 the Australian Trainers' Association lodged with the Registered Organisations Commission prescribed information requesting an election under section 187 of the *Fair Work (Registered Organisations) Act 2009* to fill the following non-office position:

Chief Executive Officer

[2] The organisation did not lodge the prescribed information before the prescribed day as required by regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009.* The prescribed information should have been lodged by 6 May 2020. In its correspondence dated 26 August 2020, the President of the organisation stated that the delay was due to a clerical error in omitting to include the non-office position of Chief Executive Officer (which is elected every four years) in the prescribed information lodged on 10 March 2020 (E2020/67), which dealt with offices elected annually.

[3] I note that while the delay in lodging prescribed information for the position of Chief Executive Officer was relatively lengthy (i.e. more than three months after it should have been lodged), I have had regard to the organisation's previous and relevant compliance history. The normal and reasonable expectation is that registered organisations will take steps to ensure that they comply with the time-frame requirements set out not only in the *Fair Work (Registered Organisations) Act 2009* (the Act) but also in instruments or references pertaining to their own governance (such as their own rules). Having considered the organisation's request for an extension, on this occasion I allow a later day for lodgement section under 189(2) of the Act.

[4] I am satisfied that an election for the abovenamed **non-office position** is required to be held under the rules of the organisation and, under subsection 189(3) of the Act, I am making arrangements for the conduct of the election by the Australian Electoral Commission (the AEC). I note that in circumstances where the AEC has not yet called for nominations in the organisation's pending election of officers (E2020/67), it may be possible to include the election for the abovenamed position in that election process. Ultimately that is a matter for the AEC.
