

Failure to comply with these obligations is subject to a civil penalty provision - see s305 of the RO Act.

Once an Annual Return or change of records has been lodged, a copy will be posted on the FWA website at <u>www.fwa.gov.au</u> - under <u>Registered organisations</u> - <u>List of registered organisations</u>.
