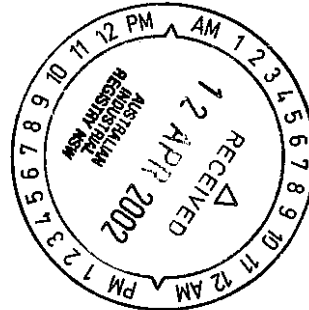

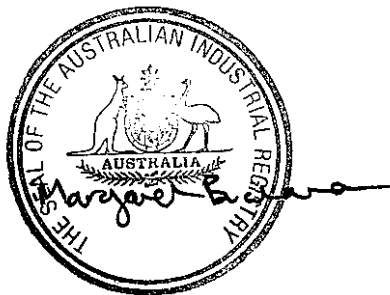
**DECISION**


