I have audited the financial accounts of the Australian Workers Union Greater NSW Branch for the year ended 30 June 2011. The Organisation Executive is responsible for the preparation and presentation of the financial statements and the information they contain. I have conducted an independent audit of the financial accounts in order to express an opinion on it to the members of the organisation.

My audit has been conducted in accordance with Australian Auditing Standards to provide reasonable assurance as to whether the financial accounts are free from material misstatement. My procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial accounts, and the evaluation of accounting policies and significant accounting estimates. Notes to the Financial Statements For the year ended 30 June 2011

# Note 1: Section 253 of Schedule 1B (the RAO Schedule) of the Workplace Relations Act 1996

Under subsection 253(1) of Schedule 1B of the Workplace Relations Act 1996 the financial reports have been prepared from the financial records kept under subsection 252(1) in relation to the financial year ended 30 June 2011. The financial reports have been prepared to comply with the Australian Accounting Standards Board and the Corporations Act 2001. The financial statements and notes for the year ended 30 June 2011 presented a true and fair view of the financial position and performance of the organisation.

The members of the organisation are provided with information to enable them to evaluate the performance of the committee of management and other holders of office in relation to the financial management of the organisation.

Under Section 253 during the financial year ended 30 June 2011 no payment by the organisation to employees as consideration for the employers making payroll deductions of membership subscriptions.

The financial reports have disclosed information in accordance with the requirements of the Industrial Registrar under Section 253 of Schedule 1B of the Workplace Relations Act 1996.

In accordance with subsection 272(5) of the RAO Schedule of the Workplace Relations Act 1996 the members' attention is drawn to subsections (1), (2), and (3) which are is set out below:

Section 272: Information to be provided to members or Registrar

(1) A member of a reporting unit, or a Registrar, may apply to the reporting unit for specified prescribed information in relation to the reporting unit to be made available to the person making the application.

(2) The application must be made in writing and must specify the period within which, and the manner in which, the information is to be given to the reporting unit.

(3) A reporting unit must comply with an application made under subsection (1).

The following is a summary of the material accounting policies adopted by the organisation in the presentation of the financial report. The accounting policies have been consistently applied, unless otherwise stated. Refer to Note: 'changes in accounting policies' for comparison to the previous financial year:

#### **Note 2: Accounting Policies and Other Disclosure Matters**

The accounts have been prepared and presented in accordance with applicable Accounting Standards, and other mandatory professional reporting requirements (Urgent Issues Groups Consensus Views), the Corporations Act 2001 and Section 253 of Schedule 1B of the Workplace Relations Act 1996. The attached financial reports adopt the accrual basis for reporting the Branch's income and expenditure whilst assets are recorded at historical cost and do not take into account changing money values nor current valuations of non current assets, except where specifically stated (refer Note 6 relating to the incorporation of freehold properties). Depreciation on office equipment, furniture and fittings are depreciated on a straight line basis. No provision for income tax is required as the Branch is exempt from income tax under Division 50-15 of the Income Tax Assessment Act 1997. The accounting policies for the Australian Workers Union Greater NSW Branch have been consistenty applied, unless otherwise stated.

Notes to the Financial Statements For the year ended 30 June 2011

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the income statement. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

#### (a) Investments

Non-current investments are measured on the cost basis. The carrying amount of investments is reviewed annually to ensure it is not in excess of recoverable amount of these investments. The recoverable amount is assessed from the quoted market value for shares in listed companies or the underlying net assets for other non-listed corporations.

#### (b) Employee Benefits

Provision is made for the liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements expected to be settled within one year have been measured at the amount expected to be paid when the liability is settled, plus related on-costs. Employee entitlements payable later than one year have been measured at the present value of the estimated future cash out flows to be made for those entitlements.

As at 30 June 2011 the Branch has provided \$938,665.86 for long service leave and entitlements of the Branch Officials and Industriial are \$703,225 and employees \$156,630. National Office accepts the responsibility for funding \$211,890 out of the Branch subsidy for Branch Officials and Industrial. The total amount provided for the Branch Officials and Industrial is \$915,115 and the Branch Employee including Clerical Staff is \$156,630.

#### (c) Comparative Figures

Comparative figures have been adjusted to conform with changes in presentation for the current financial year where required by accounting standards or as a result of changes in accounting policy.

#### (d) Legal Expenses

Legal expenses provided by the organisation include: variations to award and rules, acting on behalf of members, certified agreements and general legal advice to the organisation.

## Re: Lodgement of Financial Statements and Accounts – Australian Workers' Union, New South Wales Branch – for year ending 30 June 2011 (FR2011/2697)

The financial year of the New South Wales Branch of the organisation ended on 30 June 2011. This is a courtesy letter to remind you of the obligation to prepare the reporting unit's financial documents and to lodge audited financial accounts and statements with Fair Work Australia within the prescribed time frame unless a 1 month extension is applied for and granted.

The documents you must lodge include:

(i) A general purpose financial report; (ii) A <u>Committee of Management statement</u> (iii) An <u>operating</u> <u>report</u>; (iv) An <u>auditor's report</u>; and (v) A <u>certificate</u> in accordance with section 268.

I draw your particular attention to

(a) s237 which requires you to prepare and lodge *a separate statement* providing the prescribed particulars of any loan, grant or donation made during the year which exceeds \$1,000;

(b) s265(5) which requires you to publish or otherwise *provide your members with completed/signed copies* of the audited accounts, report and statements before final presentation and lodgment; and

(c) s266 which requires you to <u>present the completed documents to an eligible meeting(s)</u> (either of the members or of the committee of management).
