"The National Executive hereby authorises the National Secretary or his nominated official to make an application to the Industrial Registrar to vary the Rules of the Union in the following terms:

"Rule 33 - The Branches and Division of the Union, shall be varied as follows:

"Rule 33, subclause (7), subsection (h), after the list of Districts and District Officers insert the following paragraph.

"Each District shall have a district Secretary in accordance with Rule 40 and in the case of the Metals & Construction District there is to be a District President (honorary) and District Vice President (honorary) who are to be elected in the same manner as prescribed for District Secretaries in Rule 40."

"Further, that the National Secretary or his nominee make an application to the Australian Industrial Registrar to make arrangements for the election of the Metals & Construction District President (honorary) and District Vice President (honorary) such term of office is to expire 30 June 2009 and every four years thereafter."
