

Please be advised that Ronald Murphy will be terminating as the Secretary of the Union effective 31st July, 2014.



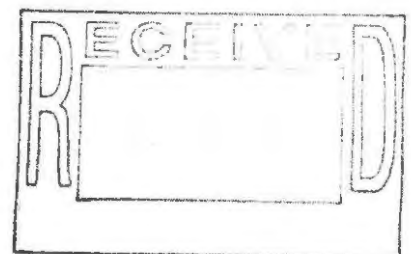

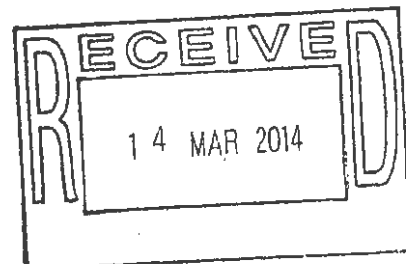
