

Annual Return of Information for 2016 [AR2016/133]

I acknowledge receipt on 24 March 2016 of your Declaration providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).

The documents lodged cover most of the required information for the 2016 Annual Return of Information of the Breweries and Bottleyards Employees' Industrial Union of Workers of Western Australia (the organisation). The documents have been filed and can be viewed on the Fair Work Commission website through the List of Registered Organisations - <http://www.fwc.gov.au/index.cfm?pagename=regorgslist>. However I make the following comments to assist with future lodgements:

Statement Regarding Subsection 151(1) Agreements

Subsection 233(1)(b) of the Fair Work (Registered Organisations) Regulations (the RO Regs) requires that prescribed records be lodged to the Fair Work Commission.

One of the prescribed records under regulation 147(g) of the RO Regs requires an organisation to state whether the organisation has entered into an agreement under subsection 151(1) which relates to State members. If so, an organisation must also lodge a record of the number of members of the organisation who were, on 31 December in the previous year, ineligible State members, in relation to the organisation, within the meaning of section 150 of the RO Act.

In order to assist organisations to fully comply with the requirements of subsection 233(1) of the Act a template annual return is available on the fact-sheets page of our website. The organisation is encouraged to use this template in future years.

Notifications of Change

Any changes to these records must be notified to the Commission within 35 days of the change. A template Notification of Change Declaration is available on the [fact-sheets](#) page of our website.
